

A MEMORANDUM OF COOPERATION AND UNDERSTANDING

Kyiv

This Memorandum is signed between the **Public Organization “European Medical Association”** (hereinafter referred to as PARTY 1), represented by the President Costigliola Vincenzo, acting on the basis of the Statute, on the one hand, the All-Ukrainian Public Organization “Association of Specialists in Traditional and Alternative Medicine of Ukraine” (hereinafter referred to as PARTY 2), represented by President Tetiana Harnyk, acting on the basis of the Statute, and the General Department of Physical Education, Sport, and Human Health of the V.I. Vernadsky Taurida National University (hereinafter referred to as PARTY 3), represented by the head of the department Nataliia Dobrovol’ska, acting on the basis of the Regulations (together referred to as PARTIES), have signed this Memorandum on cooperation, partnership, and collaboration (hereinafter referred to as MEMORANDUM).

The mission within the framework of cooperation is to discuss and highlight, both in specialized scientific-practical publications and popular ones, the promotion of a healthy lifestyle, using international experience, implementing modern achievements in preserving, promoting, and restoring the health of both combatants and civilians with the involvement of sponsors and volunteers within the legislation of Ukraine.

1. THE PURPOSE OF THE MEMORANDUM

1.1. The purpose of this MEMORANDUM is cooperation and exchange of information and experience within the competencies of the PARTIES.

Results of cooperation

2. THE SUBJECT OF THE MEMORANDUM

2.1. Pursuant to this MEMORANDUM, the PARTIES undertake to act jointly in the field of science and education to achieve the following objectives:

- consolidation of joint efforts in achieving the aim of this MEMORANDUM within their competencies;
- creation of a database for effective activities of professional public associations on the assistance system to the population in medical and physical rehabilitation, preventive health practices;
- continuous monitoring of best practices in the functioning and development, involving methods and means of complementary / alternative medicine, guided by the principles of evidence-based medicine;
- providing explanatory work among a wide circle of like-minded people on issues of assistance in the system of health practices;
- engaging leading professional experts and organizations in cooperation;

- conducting scientific and practical events aimed at disseminating the results of modern scientific research on the provision of medical services to the population;
- exchange of informational and bibliographic data according to the subject of the MEMORANDUM.

2.2. This MEMORANDUM is a manifestation of the intentions of the PARTIES to cooperate, which does not create any material or financial obligations for the PARTIES.

3. RESPONSIBILITIES OF THE PARTIES

3.1. Cooperation of the PARTIES is carried out in accordance with this MEMORANDUM and additional agreements between them.

3.2. The PARTIES undertake, within their interests and the subject of this MEMORANDUM:

- to hold joint conferences, round tables, consultations, training, webinars, seminars, etc.;
- to build their relationships on the basis of equality, academic integrity, as well as protection of the interests of each of the PARTIES;
- to publish information about joint events in the media and on the Internet;
- to organize training of specialists in the field of professional development;
- to involve leading specialists in the field of the PARTIES for the development and practical implementation of joint programs and projects.

4. TERM OF THE MEMORANDUM

4.1. The term of the MEMORANDUM is 5 year from the date of its signing.

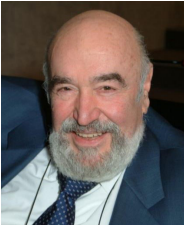
4.2. If none of the PARTIES objects in writing to the extension of the term of this MEMORANDUM one month before the expiration date, it is extended for the same period and on the same terms.
